1 Discuss and possible action reference Jonathan Pipkins (Myers Engineering) - Update on current projects. Discuss possible action regarding the new filter skid installation, RIG grant and the intake dock project. Approve invoices 223015-6 (dock), 223177-5 (filter skid) and 271 #10 from Myers Engineering: ODOT Hwy project is complete. There is a second payment due and there will be a third payout for retainage.

Intake-1st payment approved and received by K&M for \$142,833.09. Jonathan will take pics of fabrication. Army Corps Lake Manager gave us permission to clean up the intake area. Jonathan states he was not aware we needed Corps approval. Cory is concerned it could take six months to a year to receive approval to install the dock. Notice to proceed for K&M is for fabrication. Jack says we may need to issue a change order on K&M contract. Jack thinks we need to discuss what happens if the dock breaks loose. We need to have expectation in mind and plan in case this scenario occurs.

Jonathan explained that two bids were submitted for the skid install project. Quicksilver and Downey. Quicksilver bid is \$523,000.00 for #1, #2, #5 and #6 work. Downey is \$1,070,000.00 for #1 and #2. Per Jonathan, Quicksilver knows about the skid arrival date of 5/25 to 6/1. Their bid includes updating the computer equipment and software. Jonathan to bring finalized bid sheet to meeting on April 25th. The company is aware they need to be here to unload and install skid when it is delivered.
