Bid for new filters and installation \$82,000 shipping and tax not included-submit to Cherokee Nation for assistance. Get FOB for shipping price
 Need toolbox for new truck, credit card limit prevented ordering. Sham agrees to purchase and be re-imbursed
 Multiple line meters, valves fixed/replaced to reduce overall loss. One leak 10,000 gallons per day near plant
 Motion to contact Myers Engineering and begin ordering filter skid and also to agree to re-imburse Sham for tool box by Susan

Mark Mathison ORWA rate study with input from accountant Jack Roye: Debt to Income ratio for new operating budget stands at 40% needs to be around 25% or less. Need to set aside enough money for grant matching funds applied for. Need to prepare for expenditures and capital repairs to all increase. It currently costs the District \$32.91 to produce 1000 gallons of water. Suggests increase

minimum from \$49 to \$55 monthly with a sliding scale per 1000 gallons used.

- Discuss rate increase per December meeting minutes: discussed cost to replace current membrane system with a sand based filter vs perceived maintenance costs. Compared current rates vs new rates suggested by ORWA rate study. Allowed public input/interaction from multiple guests.
