Intake- K&M submitted 2 pay applications and 1 change order so far. \$269,000.00 remaining balance. We have received final Corps of Engineers approval letter for shoreline work. The intake, walkway, intake cans, pickers and I-beam trolly are all now fully fabricated. Shoreline work will begin Monday with 34 days left on contract.

Filter- control panel delivered May 14th. The pre construction meeting was held May 5th. Waiting on Dupont update on delivery 2 (turbidity panel). It was supposed to ship last week. The filter was supposed to arrive in Houston on May 14th. The project is scheduled to begin on May 19th. We should be able to unload the container and move the unit into the shop in 1 day to avoid container rental. We are working with Worth Hydrochem and Pioneer Supply for material. The contracts signed by Quicksilver Construction are waiting for our attorney's approval.
